Current commissions:

Royal Veterinary College Hawkshead Campus

Includes relocation of Equine Surgery; a new Teaching and Research Centre with part refurbishment to the existing College entrance. We are working closely with the College to investigate new types of teaching and learning spaces such as 'superlabs', as well as social learning spaces that will act as a catalyst for interaction between research students. Other studies carried out include a review of student accommodation, catering facilities, student union, and sports facilities.




Royal Veterinary College Camden Campus

Comprises a Social Learning Café, the redevelopment of an underused courtyard within an existing building to create a flexible, social learning space as an extension of the facilities surrounding it (library, refectory, teaching and office space, main entrance, common rooms and museum).



University of Portsmouth Victoria Park

New building for the Faculty of Social Science and Humanities at the University of Portsmouth, located within the context of a Listed Park. The scheme will accommodate two schools; the Institute of Criminal Justice Studies and the School of Education and Continuing Studies, and will include residential accommodation for 600 students in a combination of clusters and studios.
